

LIMITED WARRANTY

FOR P-SERIES 410A EARTHLINKED[®] HEAT PUMP PRODUCTS WITH FACTORY-INSTALLED EPS, SURE-START AND EDM

EarthLinked Technologies, Inc (ETI) hereby warrants to the consumer that the P-Series 410A EarthLinked®Heat Pump Products with factory-installed EPS, Sure-Start and EDM for units purchased on or after March 1, 2016 are free from defects in materials and workmanship, and at its discretion, will replace or repair product parts, and reimburse labor costs in accordance with the terms of this Limited Warranty. The terms of this warranty are effective from the date of installation and apply only to products purchased and installed within the **USA and Canada**. <u>The installation and all subsequent</u> <u>service and maintenance must be done by an ETI trained and authorized technician in accordance with the ETI manuals in <u>effect at the time of installation, service or maintenance, or the warranty will be void</u>. All transportation, service labor, diagnostic calls and excavation, backfilling and drilling expenses other than those specifically allowed by this Warranty are excluded.</u>

Ten-Year Parts & Five-Year Labor for Specified Product Parts and Earth Loop Protection System: If a specified EarthLinked[®] compressor unit part (defined as the Compressor, Liquid Flow Control, Active Charge Control, 3 and 4 way valves, Heat Exchanger) or HVAC product part (defined as the Air Handler or Cased Coil heat exchanger, Hydronic Water Module heat exchanger, Domestic Water Module heat exchanger, Heat Recovery Module heat exchanger, Hybrid Cooling Module heat exchanger and EarthLinked[®] Earth Loop Protection System) or Electronic part (defined as the EarthLinked Diagnostic and Monitoring system, the SureStart[™] and the nano Programmable Logic Controller) fails within ten (10) years due to a defect in manufacture or ETI's fabrication of that part, ETI will provide the replacement or repaired part to the technician. The replacement or repaired part will be warranted for the remainder of the ten year period. If ETI provides the replacement or repaired part for a failure within five years of installation due to a defect in manufacture or ETI's fabrication, ETI will also provide for the reimbursement **(in the form of credit to the claimant's account)** of labor costs to the technician, as specified in the ETI In-Warranty Allowance Schedule in effect at the time of system installation.

Two-Year Parts & Labor for HVAC Components: If any other EarthLinked[®] Heat Pump product part (defined as all other compressor unit and HVAC product parts and the thermostat) fails within two (2) years due to a defect in manufacture or ETI's fabrication of that HVAC part, ETI will provide the replacement or repaired part to the technician. The replacement or repaired part will be warranted for the remainder of the two-year period. If ETI provides the replacement or repaired part for a failure within two years of installation due to a defect in manufacture or ETI's fabrication, ETI will also provide for the reimbursement (in the form of credit to the claimant's account) of labor costs to the technician, as specified in the ETI In-Warranty Allowance Schedule in effect at the time of system installation.

Exclusions: This Warranty shall not apply to damaged or missing required product parts caused by transportation, improper or inadequate specification, sizing, installation, maintenance, service or alteration, any work done by unauthorized technicians, or acts of God; improper electrical supply, refrigerant or lubricant charge; use of products in a contaminated or corrosive atmosphere or fluid supply; operation of an ETI system at abnormal gas or liquid temperatures, pressures or flow rates; improper backfill, grouting or compaction of earth loops; use of the earth loops in a corrosive soil without ETI's Earth Loop Protection System, earth loops subjected to electrical currents, or field-specified earth loops without prior written approval from ETI. This Warranty does not apply to field-supplied products or parts installed in an ETI system. Field-supplied products must receive prior approval from ETI, otherwise the warranty will be deemed void.

THERE ARE NO WARRANTIES WHICH EXTEND BEYOND THE FACE HEREOF AND THIS LIMITED WARRANTY IS IN LIEU OF ANY AND ALL OTHER WARRANTIES AND LIABILITIES. THE FOREGOING STATES ETI'S ENTIRE AND EXCLUSIVE LIABILITY AND

BUYER'S EXCLUSIVE AND SOLE REMEDY. ETI WILL IN NO EVENT BE LIABLE FOR ANY CONSEQUENTIAL, SPECIAL OR CONTINGENT DAMAGE OR EXPENSE ARISING DIRECTLY OR INDIRECTLY FROM ANY DEFECT IN ITS GOODS OR FROM THE USE THEROF, NOR IS ANY OTHER PERSON AUTHORIZED TO ASSUME FOR ETI ANY SUCH LIABILITY.

IN NO EVENT, WHETHER AS A RESULT OF BREACH OF WARRANTY OR CONTRACT, NEGLIGENCE OR STRICT LIABILITY, SHALL ETI BE LIABLE FOR SPECIFIC, INCIDENTAL, OR CONSEQUENTIAL DAMAGES, INCLUDING, BUT NOT LIMITED TO, PROPERTY DAMAGE, LOSS OF USE OF THE EQUIPMENT OR ASSOCIATED EQUIPMENT, LOST REVENUES OR PROFITS, COST OF SUBSTITUTE EQUIPMENT OR COST OF FUEL OR ELECTRICITY. THE ABOVE LIMITATIONS SHALL INURE TO THE BENEFIT OF ETI'S SUPPLIERS, DEALERS, AGENTS AND SUBCONTRACTORS. THE ABOVE LIMITATION ON CONSEQUENTIAL DAMAGES SHALL NOT APPLY TO INJURIES TO PERSONS IN THE CASE OF CONSUMER GOODS.

SOME JURISDICTIONS DO NOT ALLOW THE EXCLUSION OR LIMITATION OR LIABILITY FOR CONSEQUENTIAL OR INCIDENTAL DAMAGES OR LIABILITY FOR STRICT LIABILITY IN TORT, SO THAT THE ABOVE EXCLUSIONS AND LIMITATIONS MAY NOT APPLY IN SUCH JURISDICTIONS.

ETI DOES NOT ASSUME, OR AUTHORIZE ANY OTHER PERSON TO ASSUME FOR ETI, ANY OTHER LIABILITY FOR AND/OR REGARDING THE SALE OF THIS PRODUCT AND/OR RELATED PRODUCT.
